Effectively immediately, RPC will continue worship in the Sanctuary each Sunday at 10:00 AM with masks and/or face shields required, social distancing marked by alternate pews, no congregational or choir singing, only instrumental or recorded music, and no fellowship hour.

Any indoor memorial services will follow the same stipulations.

Special Guidance to the current Facilities Use Policy: COVID-19 Special Guidance Pertaining to the use of RPC Facilities (as of August 2021)

In consideration of the impact of the Delta variant, guidelines and special orders from all levels of government, as well as recommendations from The Presbytery of the James make it prudent for us to change some aspects of how we handle the use of our facilities to ensure safety for our staff, congregants, and visitors.

Even though in June 2021 RPC reopened the Sanctuary for worship services, we will continue to turn away requests for any outside group to use the facility. The kitchen facilities should not be used for any food preparation and all meetings/gatherings should use the Fellowship Hall to encourage social distancing. **Mask or face shield usage is required while inside** as it has been shown to decrease the volume of transmissible virus particles.

This is an exceptional time and we appreciate your cooperation with these changes to keep us all as safe as possible. (This situation will be closely monitored and changes to this policy will be made accordingly.)

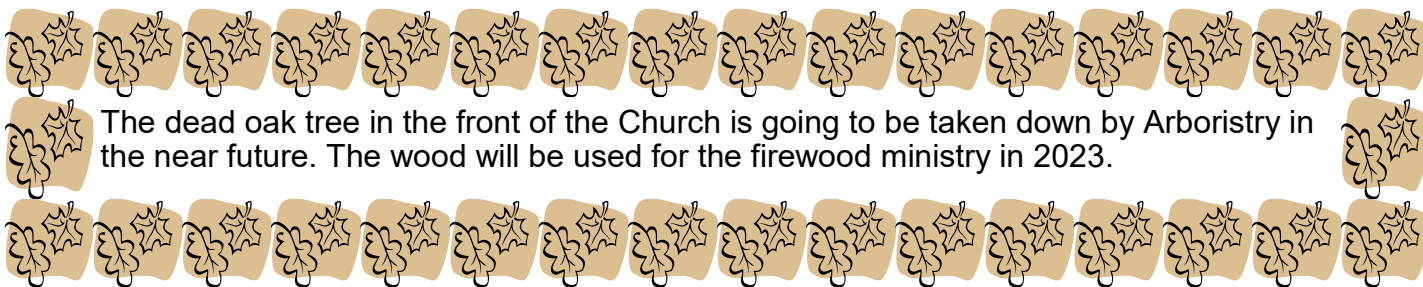

On August 17th, Session approved the Ministry Information Form (MIF), prepared by the PNC over the last several weeks. This document, based upon the Mission Study Team Report, provides potential pastoral candidates a portrait of RPC and our congregation, its mission and character, as well as prioritizing the talents we are seeking in our new pastor. The MIF has now been submitted to the Presbytery for posting online as an available position. We hope to begin receiving responses, known as Pastor Information Forms (PIFs), by early September. Our next task will be to review PIFs as they are received, with an eye to discerning the candidate God has already chosen to lead us. As we begin this next phase, we ask for your prayers that we may continue to be guided by the Holy Spirit in this important task.

Session Highlights 8/17/21

Moderator Rev. Jewell-Ann Parton called the Session Meeting to order at 7:00 P.M. Elder Leslie Buchanan presented the Opening Prayer and Devotions. Joys and Concerns were shared. Prayers were asked for Sam and Kelley Alexander, Katy Jo and Al Gale, Abby Carr, Kate Humphrey Chambers, and Leslie Buchanan and Nancy Johnson.

Clerk's Report:

- Approved Amended Minutes of the Stated Meeting 6/18/21.
- Approved Minutes of the Congregational Meeting 6/27/21.

Pastor's Report: Rev. Rev. Jewell-Ann Parton noted that elder training has concluded and that she enjoyed her 'stay-cation'. She officiated two memorial services, one at Tabor PC and one at RPC. She will officiate a graveside service for Cheryl Borgman's mother on 9/5/21 with a reception in the Pavilion.

Stewardship/Finance: Elder Lee Goodrich presented the Stewardship Report, which included the following motions that Session approved:

- 2021 Stewardship Campaign Schedule
- On Commitment Sunday, November 14, the church will have a 'Brunswick Stew' celebration event at RPC. Folks will bring items for the stew, help in set-up and clean-up, and serve. Dave Priddy will cook the pork.

He noted that budget requests will be due 10/8/21 so that the Committee can challenge the congregation to increase pledges sufficiently to meet the budget. The projected increase in salary to attract a new pastor will require a substantial increase in income versus this year's budget.

New Business:

- Elders Greg Frahm and Kate Humphrey Chambers are assigned as Commissioners to the virtual POJ Meeting 10/16/21. Commissioners for 2/19/22 will be Bill Iverson and Lynne Hess; for 6/21/22 Mac Lumpkin and Ken Engebretson.
- Elders and PNC members Leslie Buchanan and Lee Goodrich presented the church's Ministry Information Form. Session approved the MIF with slight wording changes.

Ministry Team Reports/Motions:

- Elders Greg Frahm and Mike Smythers (Grounds Ministry Team) reported 2 bids for the removal of the dead oak tree in the front of the church: Arboristry \$1,975, which includes cutting the tree into log lengths of 8 feet, leaving the stump, and (for perhaps another \$100) moving the wood to the woodpile and Creation Appreciation \$2,474-2,775, same service, both of which are outside the budget for Grounds. Session approved \$2,500 maximum to remove the tree and move the wood to the woodpile. They also requested purchasing 9 yards of mulch to be spread around the perimeter of the building: \$350-400 range and Session approved it.
- Elder Bob Alpers (Mission Ministry Team) reported that the Mission Committee completed the Head Start Back Pack Project for some 86 Nelson County students and thanked the congregation for its generosity, noting that the Committee has \$300 for next year. Also, the Committee voted to expand the Light in the Valley Scholarship eligibility to include students applying to Virginia four-year colleges and universities but still giving preference to junior college applicants. The Bridgewater student discussed at the last meeting needs to be fully enrolled before RPC awards the scholarship money for him.



Session Highlights 8/17/21 (Cont'd)

- Elder Ken Engebretson (Building Ministry Team) presented the following amended Special Guidance addition to the current Facilities Use Policy, which Session approved:

- Elder Phyllis Savides (Worship Ministry Team) presented a motion to return to outdoor services in the Pavilion starting on 9/12/21. After much discussion the motion was denied by a 7-4 vote. Further, Phyllis presented 4 motions that Session approved:
 1. We will continue with a single service.
 2. We will continue with the time of the service to be 10:00 a.m.
 3. Everyone will wear a mask indoors. Kathleen will buy 3 different types of singers' masks to try out for the choir.
 4. Rev. Jewell-Ann Parton will be on vacation 9/19/21, 10/31/21, 11/28/21, and 12/26/21. We will ask Rev. Gordon Lindsay to preach on those Sundays.

A motion was made from the floor (effective 8/19/21), which Session unanimously approved, stating:

Everyone entering RPC will wear a mask and/or face shield while inside and maintain social distancing as much as possible, keeping alternate rows of pews either empty or with six feet of distance between people not in one's household. There will be no singing (humming is OK), all music will be instrumental or recorded and there will be no fellowship hour. These guidelines will be followed at memorial services as well. Communion will be symbolic with only Rev. Jewell-Ann Parton partaking.

As we move forward, we will continue to monitor the situation and amend this motion as needed.

Ushers are also needed and a request will be sent out by Jamie Heard.
